

Application Notes for Jabra Engage 50 II (Engage 50 II Link) UC Stereo/Mono USB-A/USB-C headset and Jabra Direct for Mac with Avaya Workplace Client for Mac - Issue 1.0

#### Abstract

These Application Notes describe the configuration steps required to integrate Jabra Engage 50 II (Engage 50 II Link) UC Stereo/Mono USB-A/USB-C headset and Jabra Direct for Mac with Avaya Workplace Client for Mac.

Readers should pay attention to **Section 2**, in particular the scope of testing as outlined in **Section 2.1** as well as any observations noted in **Section 2.2**, to ensure that their own use cases are adequately covered by this scope and results.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the DevConnect Program at the Avaya Solution and Interoperability Test Lab.

# 1. Introduction

Jabra Engage 50 II (Engage 50 II Link) UC Stereo/Mono USB-A/USB-C headset and Jabra Direct for Mac allows connection and call control with Avaya Workplace Client for Mac (hereafter referred to as Avaya Workplace) via the USB interface to the Mac. In this compliance test, only Jabra Engage 50 (Engage 50 II Link) UC Stereo USB-A headset is used since there are similarities between Jabra Engage 50 II (Engage 50 II Link) UC Mono and Stereo models (see **Attachment 1**, Jabra Engage 50 II (Engage 50 II Link) UC Declaration of Similarity).

With a Jabra Engage 50 II (Engage 50 II Link) UC Stereo/Mono USB-A/USB-C headset connected to the Mac USB interface, users can directly answer, end, mute/unmute, hold/resume and adjust volume with Avaya Workplace running on the Mac.

# 2. General Test Approach and Test Results

The interoperability compliance test included feature and serviceability testing. The feature testing focused on placing calls with Avaya Workplace, answering and ending calls using the call control buttons on Engage 50 II (Engage 50 II Link) UC, and verifying two-way audio. The call types included calls to voicemail, local extensions, and the PSTN. Call hold and resume, mute and un-mute, and volume are also tested.

The serviceability testing focused on verifying the usability of the headset solution after restarting Avaya Workplace, restarting the Mac, and disconnecting/reconnecting the Engage 50 II (Engage 50 II Link) UC USB connection to the Mac.

DevConnect Compliance Testing is conducted jointly by Avaya and DevConnect members. The jointly defined test plan focuses on exercising APIs and/or standards-based interfaces pertinent to the interoperability of the tested products and their functionalities. DevConnect Compliance Testing is not intended to substitute full product performance or feature testing performed by DevConnect members, nor is it to be construed as an endorsement by Avaya of the suitability or completeness of a DevConnect member's solution.

Avaya recommends our customers implement Avaya solutions using appropriate security and encryption capabilities enabled by our products. However, Avaya does not conduct the testing of non-Avaya headsets/handsets for: Acoustic Pressure, Safety, Hearing Aid Compliance, EMC regulations, or any other tests to ensure conformity with safety, audio quality, long-term reliability or any regulation requirements. As a result, Avaya makes no representations whether a particular non-Avaya headset will work with Avaya's telephones or with a different generation of the same Avaya telephone.

Since there is no industry standard for handset interfaces, different manufacturers utilize different handset/headset interfaces with their telephones. Therefore, any claim made by a headset vendor that its product is compatible with Avaya telephones does not equate to a guarantee that the headset will provide adequate safety protection or audio quality.

## 2.1. Interoperability Compliance tests

All test cases were performed manually. The following features were verified:

- Placing calls to internal extensions to verify two-way audio.
- Placing calls to the PSTN to verify two-way audio.
- Answering and ending calls using the call button on the headset and the soft button on Avaya Workplace.
- Using the hold button on the headset and the soft button on Avaya Workplace to hold and resume the audio.
- Using the volume buttons on the headset to adjust the audio volume.
- Using the mute button on the headset and the soft button on Avaya Workplace to mute and un-mute the audio.
- Verifying incoming call notification on the headset.
- Verifying call ended notification on the headset.
- Placing calls to the voicemail system. Voice messages were recorded and played back to verify that the playback volume and recording level were good.

The serviceability testing focused on verifying the usability of the headset solution after restarting Avaya Workplace, restarting the Mac, and disconnecting/reconnecting the Engage 50 II (Engage 50 II Link) UC USB connection to the Mac.

#### 2.2. Test Results

All test cases were completed successfully with the following observation noted:

• Engage 50 II (Engage 50 II Link) UC incorporates a Smart Ringer feature which audibly alerts the user from the Engage 50 II Link on an incoming call when the headset is not being worn, e.g., sitting flat on a desk. With a call ringing, any volume adjustments using the Engage 50 II Link controls are for the Smart Ringer Ringtone volume. If Smart Ringer is disabled, volume adjustments using Engage 50 II Link during ringing do affect the call volume. Refer to [5] for more information on Smart Ringer.

# 3. Reference Configuration

**Figure 1** illustrates the test configuration used to verify Jabra Engage 50 II (Engage 50 II Link) UC Stereo USB-A headset with Avaya Workplace. The Avaya Workplace software was installed on the Mac. Jabra Engage 50 II (Engage 50 II Link) UC Stereo USB-A headset communicates via USB connection to the Mac hosting Avaya Workplace.




Figure 1: Test Configuration

# 5. Configure Avaya Aura® Session Manager

## 5.1. Add SIP User

The addition of SIP Users will not be detailed here. Refer to details in adding users in the administration document for Avaya Aura® Session Manager in [2] listed in Section 10 for details.

# 6. Configure Avaya Workplace Client

Avaya Workplace is a SIP soft phone application that provides users with access to Unified Communications (UC) services. This section shows how to configure Engage 50 II (Engage 50 II Link) UC headset to interoperate with Avaya Workplace. Before configuring the Avaya Workplace Client, the headset has to be configured as in **Section 7** first.

Log in to Avaya Workplace with a valid SIP user. From Avaya Workplace, navigate to **Settings**  $\rightarrow$  User Preferences  $\rightarrow$  Audio/Video.

# 7. Configure Jabra Engage 50 II (Engage 50 II Link) UC Stereo USB-A Headset Environment

This section covers the steps to integrate Engage 50 II (Engage 50 II Link) UC with Avaya Workplace, including:

- Installing Jabra Direct software
- Connecting the Jabra headset


**Note:** After successfully performing this procedure, Engage 50 II (Engage 50 II Link) UC will be detected in Avaya Workplace as described in **Section 6**.

## 7.1. Install Jabra Direct Software

Jabra Direct software can be obtained from the Jabra support portal at <u>https://www.jabra.com/support/</u>. Installation of the software is done through executing the setup file and following the prompts.

## 7.2. Connect the Jabra Headset

Plug Engage 50 II (Engage 50 II Link) UC headset in the USB port of the Mac. Open the Jabra Direct application. Select the **Device** icon on the left side of the window. The window should display *Jabra Engage 50 II*.



# 8. Verification Steps

This section provides steps to verify that the Jabra solution has been successfully integrated with Avaya Workplace.

#### 8.1. Initialization

Open Avaya Workplace and log in. Once logged in, open Jabra Direct. Select the Device icon on the left side of the window (not shown). Click on the *Jabra Engage 50 II* image. The softphones should show *Ready* for **Avaya Equinox**, the former name for Avaya Workplace.



## 8.2. Call Control

Calling using Avaya Workplace or Engage 50 II (Engage 50 II Link) UC controls should function.

- Make calls from and to Avaya Workplace and verify two-way audio using Engage 50 II (Engage 50 II Link) UC headset.
- Make a call to Engage 50 II (Engage 50 II Link) UC and verify the call can be answered and dropped using the Inline Link controls.
- Make a call and verify mute can be initiated from the Inline Link controls.
- Make a call and verify Avaya Workplace puts the caller on and off hold when initiated from the Inline Link controls.

It is hereby declared that the:

Jabra Engage 50 II UC headset is available in Stereo and Mono versions and each version is also available with either USB-A or USB-C connectivity. Users can choose versions bundled with controllers that connect to the headset via USB-C or choose to have headsets without bundled controls. The versions with the bundled controllers are identified with "Engage 50 II Link" in the product descriptions.

Jabra Engage 50 II UC headset support USB connection to a PC running a soft client such as Avaya Workplace Client for Mac OS. The Engage 50 II UC has LED light for indication of, including incoming call, answer, end, and mute. This functionality is the same when connected to the Engage 50 II UC Stereo and Mono.

The Engage 50 II UC Stereo and Mono headsets use identical firmware.
