Application Notes for Configuring Jabra Link 380 Bluetooth dongle and Jabra Evolve2 55 UC Mono/Stereo Bluetooth Headsets with Avaya Workplace Client for Windows - Issue 1.0

Abstract

These Application Notes describe the configuration steps required to integrate Jabra Link 380 Bluetooth dongle and Jabra Evolve2 55 UC Mono/Stereo Bluetooth Headsets with Avaya Workplace Client for Windows.

Readers should pay attention to **Section 2**, in particular the scope of testing as outlined in **Section 2.1** as well as any observations noted in **Section 2.2**, to ensure that their own use cases are adequately covered by this scope and results.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the Avaya DevConnect Program.

1. Introduction

The Jabra Evolve2 55 UC Bluetooth Headsets allows connection and call control of Avaya Workplace Client for Windows (hereafter referred to as Avaya Workplace) via USB Bluetooth dongle that interfaces to the PC. In the compliance test, Jabra Evolve2 55 UC Stereo Bluetooth Headsets with Jabra Link 380 dongle with both USB-A and USB-C type interfaces were tested.

Avaya Workplace 3.30 onward for both Windows and Mac has embedded headset support for Jabra. With a Jabra headset connected to the PC USB interface via Bluetooth, users can directly answer, end, mute/unmute, and adjust volume with the headset.

2. General Test Approach and Test Results

The interoperability compliance test included feature and serviceability testing. The feature testing focused on placing calls with Avaya Workplace, answering and ending calls using the call control button on the Jabra headset, and verifying two-way audio. The call types include calls to voicemail, local extensions, and the PSTN. Mute and un-mute, and volume are also tested.

The serviceability testing focused on verifying the usability of the Jabra headset solution after restarting the Avaya Workplace, restarting the PC, moving the headset out of Bluetooth range and reconnecting the USB Bluetooth dongle to the PC.

Avaya recommends our customers implement Avaya solutions using appropriate security and encryption capabilities enabled by our products. The testing referenced in these DevConnect Application Notes included the enablement of supported encryption capabilities in the Avaya products. Readers should consult the appropriate Avaya product documentation for further information regarding security and encryption capabilities supported by those Avaya products.

Support for these security and encryption capabilities in any non-Avaya solution component is the responsibility of each individual vendor. Readers should consult the appropriate vendor-supplied product documentation for more information regarding those products.

For the testing associated with these Application Notes, the interface between Avaya systems and endpoints utilized enabled capabilities of TLS/SRTP.

The jointly-defined test plan focuses on exercising APIs and/or standards-based interfaces pertinent to the interoperability of the tested products and their functionalities. Since there is no industry standard for handset interfaces, different manufacturers utilize different handset/headset interfaces with their telephones. Therefore, any claim made by a headset vendor that its product is compatible with Avaya telephones does not equate to a guarantee that the headset will provide adequate safety protection or audio quality.

2.1. Interoperability Compliance Testing

All test cases were performed manually. The following features were verified:

- Placing calls to the voicemail system. Voice messages were recorded and played back to verify that the playback volume and recording level were good.
- Placing calls to internal extensions to verify two-way audio.
- Placing calls to the PSTN to verify two-way audio.
- Answering and ending calls using the call button on the headset and the soft button on Avaya Workplace.
- Using the soft button on Avaya Workplace to hold and resume the audio.
- Using the volume buttons on the headset to adjust the audio volume.
- Using the mute button on the headset and the soft button on Avaya Workplace to mute and un-mute the audio.
- Verifying incoming call notification.
- Verifying call ended notification.

The serviceability testing focused on verifying the usability of the headset solution after restarting Avaya Workplace, restarting the PC, moving the headset out of Bluetooth range and reconnecting the USB Bluetooth dongle to the PC.

2.2. Test Results

All test cases were completed successfully.

3. Reference Configuration




Figure 1: Test Configuration

Figure 1 illustrates the test configuration used to verify the Jabra Link 380 Bluetooth dongle and Jabra Evolve2 55 UC Bluetooth Headsets with Avaya Workplace. The Avaya Workplace software was installed on the PCs. The Jabra headsets are connected via Bluetooth using Jabra Link 380 plugged into the PCs' USB interface. Jabra Link 380 Bluetooth dongle with USB-A and USB-C type were tested with the headsets.

5. Configure Avaya Aura® Session Manager

The addition of SIP Users will not be detailed here. Refer to details in adding users in the administration document for Avaya Aura® Session Manager in [2] listed in Section 10 for details.

6. Configure Avaya Workplace Client

Avaya Workplace is a SIP soft phone application that provides users with access to Unified Communications (UC) services. This section shows how to configure the Jabra Evolve2 55 UC Bluetooth Headsets to use with Avaya Workplace.

Before configuring Avaya Workplace, the headset has to be configured and provisioned as in Section 7 first. From Avaya Workplace, navigate to Settings \rightarrow User Preferences \rightarrow Audio/Video.

Select *Jabra Link 380* for Microphone \bigcirc and the same for Speakers \bigcirc as shown below. It is optional for Ringing on incoming calls \bigtriangleup to be set as *Jabra Link 380*. The screenshot below shows Jabra Link 380 connected to the PC.

7. Configure Jabra Evolve2 55 UC Bluetooth Headsets

Plug the Jabra Link 380 into the USB port of the PC. The device drivers will automatically be installed. Power on the Jabra Evolve2 55 UC Bluetooth Headsets and the device will automatically connect to the Jabra Link 380. Otherwise, consult the manual [5] to re-configure the Bluetooth connection in **Section 10.** Verify from the Sound Settings for Windows that the Jabra Link 380 is detected as below. After the Jabra headset is successfully installed it will be detected in Avaya Workplace as described in **Section 6**.

8. Verification Steps

This section verifies that the Jabra solution has been successfully integrated with Avaya Workplace.

- Open Avaya Workplace and observed that Jabra Evolve2 55 headset is detected as detailed in Section 6.
- Make incoming and outgoing calls and verify that calls can be established with two-way audio. For incoming calls, answer the call by pressing the right button on the headset or answer the call using the microphone boom arm (default settings) shown below.
- End the call by pressing the right button on the headset.
- Verify also that the headset is able to remotely control call functions such as answer/drop, mute/un-mute and volume adjustment. Similarly, verify such call control functions could be done on Avaya Workplace and the PC for volume.
